
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of A. J. HALL CORPORATION, a California corporation, executed in favor of The City of San Diego, bearing date of December 21, 1979, granting to said City a permanent easement for public street purposes over, along and across those portions of Lots 2 through 10 inclusive and 39 through 47 inclusive in Block 4 of Swan's Addition, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named CHAMOUNE AVENUE.

BE IT FURTHER RESOLVED, that the existing alley south of Quince Street at Chamoune Avenue, located in Block 4 of Swan's Addition, Map No. 947, is hereby named CHAMOUNE AVENUE.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
