

RESOLUTION NO. R- 251444 (R.80-1646)

WHEREAS, SCOTT P. CROWDER and L. DAVID MAHLUM, private individuals, have requested an exchange of drainage easements; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easements to be acquired will serve the same use and purpose as the easements to be quitclaimed by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That the acceptance by the City Manager of that deed of SCOTT P. CROWDER and L. DAVID MAHLUM, private individuals, executed in favor of The City of San Diego, bearing date of January 29, 1980, conveying to said City drainage easements in a portion of Villa Lot 29 of University Heights Map 937, and Parcel 1 of Parcel Map 9179, as more particularly described in said deed, is hereby approved.

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR-251444 -1, quitclaiming to SCOTT P. CROWDER and L. DAVID MAHLUM, private individuals, all of the City's right, title and interest in the drainage easements in a portion of Villa Lot 29 of University Heights Map 937, and Parcel 1 of Parcel Map 9179, as more particularly described

in said deed.

3. That the City Clerk of said City is hereby authorized and directed to deliver said deeds, and a certified copy of this resolution to the Engineering and Development Department for further handling.
