
BE IT RESOLVED, by the Council of The City of San Diego as follows:

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$152,000 from Capital Outlay Fund 245 CIP 33-064(0) P26 to cover said acquisition costs is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
