That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with ARVIN BASNIGHT ASSOCIATES for consulting services in conjunction with airport problems in an amount not to exceed \$10,000, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-251457, and to waive the requirements of Council Policy 300-7, Consultant Services Selection, in order to retain the services of Arvin Basnight Associates.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is hereby authorized to transfer the sum of \$10,000 from the Unallocated Reserve Fund to the Allocated Reserve Fund, solely and exclusively to be used for the above purpose.
