

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with THE REGENTS OF THE UNIVERSITY OF CALIFORNIA AT SAN DIEGO (UCSD) to construct a bicycle/pedestrian path between the La Jolla Village Bridge and the University, and an agreement with the SAN DIEGO TRANSIT CORPORATION (SDTC) to maintain the bicycle/bus rack program, under the terms and conditions set forth in the agreements on file in the office of the City Clerk as Document No. RR-251462-1 and No. RR-251462-2, respectively.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to transfer \$24,500 from the Fiscal Year 1980 Local Transportation Fund to the following: (1) \$16,000 to UCSD and (2) \$8,500 to SDTC, solely and exclusively for the above purpose.
