

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with INNIS-TENNEBAUM, ARCHITECTS, INC. for an amount not to exceed \$48,000 to provide a program including cost estimating, scheduling, plans, specifications, inspections and related services for the Civic Theatre-Rehabilitation, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-251466.

BE IT FURTHER RESOLVED, that the expenditure of \$48,000 is hereby authorized from Transit Occupancy Tax Fund 223, solely and exclusively for the purpose set forth above.
