
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Grant Deed of MILLER GUEST HOMES, INC., a California corporation, executed in favor of The City of San Diego, bearing date of December 21, 1979, conveying to said City Lots 49, 50, 52, 53 and 54, and a portion of Lot 48 of Encanto Park Addition to Encanto Heights, according to Map thereof No. 1228, filed in the Office of the San Diego County Recorder, as more particularly described in said deed, be, and the same is hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$54,338 from Subdivision Park Fee Fund 11681, \$21,688 from Building Permit Park Fee Fund 15681, \$23,008 from Building Permit Park Fee Fund 15671, and \$15,466 from Building Permit Park Fee Fund 15670, to cover the cost of acquiring said land, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
