

WHEREAS, the recent extraordinary storms have caused flooding in the Tia Juana River Valley and have destroyed access across the Tia Juana River; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That a state of emergency and urgent need exists with respect to the immediate restoration of Dairy Mart Road across the Tia Juana River.

2. That the public interest or necessity demands the immediate expenditure of public funds to safeguard life, health or property.

3. That the specifications are approved and the competitive bids provisions of Section 94 of the City Charter are waived to allow the Purchasing Agent to seek bids without advertising for formal bids for the purpose of the emergency reconstruction of Dairy Mart Road across the Tia Juana River.


4. That the City Manager is authorized to execute a contract with the lowest responsible and responsive bidder.

5. That an expenditure not to exceed \$150,000 from Capital Improvement Project 52-199.1 is authorized for purposes of executing this contract.

6. That the City Auditor and Comptroller is hereby authorized to transfer \$150,000 in Capital Outlay funds

from CIP 37-137, Crystal Pier; to CIP 52-199.1, Reconstruction of Dairy Mart Road, solely and exclusively for the above-mentioned project.
