

RESOLUTION NO. R-251470

WHEREAS, the California Coastal Commission in the spring of 1978 approved the Mission Bay and Pacific Beach Issue Identifications requiring the City to prepare a Coastal Access Study for the Mission Bay/Pacific Beach Planning areas to be funded by a Coastal Commission grant; and

WHEREAS, the California Coastal Commission has approved a grant to The City of San Diego for \$30,000 for the purpose of implementing an experimental shuttle bus service to these areas during the summer of 1980; the Planning Department, as part of its Local Coastal Program, is requesting proposals for implementation of such a shuttle; and

WHEREAS, the City and Coastal Commission staffs have worked out a mutually satisfactory work program; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager, or his designated representative, be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the California Coastal Commission for the Commission's funding of said Coastal shuttle service.
