BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Council acting for and on behalf of the San Diego Open Space Park Facilities District No. 1, and in accordance with the San Diego Park Facilities District Procedural Ordinance as set forth in Section 61.2000 et seq. of the City Municipal Code, having heard all protests against the acquisition of that property described in that Resolution of Intention No. 251357 adopted by the City Council on March 10, 1980, hereby overrules such protests and determines that the public interest and convenience requires the acquisition of said property for open space park purposes.

BE IT FURTHER RESOLVED, that the Mayor shall execute and the Clerk shall attest and cause to be acknowledged, a deed or deeds conveying said properties to the District and the City Manager is authorized to accept and cause the same to be recorded without further Council action.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$977.500 as payment for said property and related costs from Open Space Park Facilities District No. 1 Bond Fund 79101 is hereby authorized and approved.


