

RESOLUTION No. R-251481 (R-80-1680)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the contract with HACIENDA LANDSCAPE COMPANY for COMPLETE LANDSCAPE MAINTENANCE OF FOURTEEN (14) SELECTED CITY SITES awarded pursuant to Resolution No. 251233, adopted February 19, 1980, is hereby terminated in view of HACIENDA LANDSCAPE COMPANY'S refusal to perform said contract. HACIENDA LANDSCAPE COMPANY is hereby deemed to be in default.

That the low acceptable bid of ENVIRONMENTAL CARE, INC., is hereby accepted; and the City Manager is hereby authorized to execute a contract for furnishing COMPLETE LANDSCAPE MAINTENANCE OF FOURTEEN (14) SELECTED CITY SITES as may be required for a period beginning March 1, 1980 through January 31, 1981 for sites 2 and 4, per prices on file in the Purchasing Department; terms 2% 20 days, with an option to renew contract for two (2) additional one (1) year periods.
