APPROVING MAP OF VISTA VIEW CONDOS

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by RONALD C. PARKER, a Licensed Land Surveyor, entitled "VISTA VIEW CONDOS Being a subdivision of the northerly half of Lot 14 in Block 'S' of the resubdivision of Villa Lots 51 to 57, and 59 to 66, inclusive, Pueblo Lots 1110-1113 University Heights, according to Map thereof No. 1064, filed in the office of the County Recorder of San Diego County on June 10, 1907, together with a portion of Villa Lot 70 of University Heights according to Map thereof No. 951 filed in said County Recorder's Office on June 1, 1905, all in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement for open space over, under and upon a portion of Lot 1, as granted and shown on said map and subject to the conditions set forth thereon.


The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council,
