

RESOLUTION No. R- 251500 (R- 80-1724)


Adopted on MAR 31 1980

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of SAFEGUARD, a partnership, executed in favor of The City of San Diego, bearing date of October 20, 1979, granting to said City the permanent easement and right-of-way for a public street and incidents thereto, over, under, upon, along and across that portion of Parcel 2 of Parcel Map No. 4245, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named DYKES AVENUE.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
