WHEREAS, the Council of The City of San Diego on June 19, 1978 authorized the City Manager by Resolution No. 221139, to execute a requirements contract with JONES CHEMICALS, INC.; and

WHEREAS, said agreement contemplated that Jones Chemicals, Inc. would provide to The City of San Diego approximately 100,000 gallons of Liquid Caustic Soda for a one-year period with an optional one-year period if the option to renew the contract was exercised by the City; and

WHEREAS, Jones Chemicals, Inc. has already provided 130,000 gallons of liquid caustic soda to The City of San Diego in the option year August 1, 1979 through July 31, 1980 of the contract; and

WHEREAS, Jones Chemicals, Inc. has by letter dated February 20, 1980 requested The City of San Diego to be released from its obligations established by the terms of said agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to terminate the agreement with Jones Chemicals, Inc.
