BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute an agreement with ERNEST W. HAHN, INC., a California corporation, pursuant to which The City of San Diego will guitclaim all of its right, title and interest in certain lands consisting of 204 acres and approximately 52 acres which were conveyed by The City of San Diego to The City of Escondido in 1967 and 1975 respectively, and pursuant to which San Diego agrees to convey certain easements for street purposes to The City of. Escondido, which easements are needed in connection with a proposed shopping center on a portion of the above described property, and pursuant to which Ernest W. Hahn, Inc. agrees to pay to The City of San Diego One Hundred Thousand Dollars (\$100,000) per year, plus 5% of defined overages, as and when rent amounts are paid to The City of Escondido, pursuant to a proposed ground lease, a copy of which is on file in the office of the City Clerk as Document No. RR-251518-1, under the terms and conditions set forth in that agreement on file in the office of the City Clerk as Document No. RR-251518-2.

BE IT FURTHER RESOLVED, that this authorization is subject to and contingent upon the execution of said agreement by Ernest W. Hahn, Inc. within thirty (30) days following the adoption of

this resolution, and is further contingent upon the execution, by The City of Escondido, of an agreement relating to the conveyance of 77-1/2 acres of land, a copy of which agreement is on file in the office of the City Clerk as Document No. RR-251518-2.
