Edna Gonzales	Police	\$145	Ms. Gonzales is an Intermediate Typist. She suggested that the processing of FBI slips be eliminated. This is expected to save \$2,899 per year in checking and filing time. This is a partial award pending a final 12-month review.
William V. Nery	General Services	\$105	Mr. Nery is an Equipment Mechanic in the Equipment Division. One year ago he earned a \$40 partial award for his suggestion to use quick disconnecting couplings for the filling and draining of oil in fixed Cab Masters. One year's experience has shown a total savings of \$1,426. This is the remainder of his award.
