

RESOLUTION NO. R-251524Adopted on APR 11 1980

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Phillip J. Love	General Services	\$85	Mr. Love was a Carpenter Supervisor in the Buildings Division. He suggested that plastic replacement seats be used at the Starlight Bowl. This saves \$846 in repair costs.
Ronald G. Smith	General Services	\$85	Mr. Smith is a Carpenter in the Buildings Division. He suggested that a manifold system be used by the Fire Department in refilling oxygen bottles. This saves \$872 annually in the time required to refill bottles.
Davis E. Darnell Robert N. Snowden James Phillips Anthony Clews Desmond Marmion	General Services	\$75	The suggesters are Litter Enforcement Section supervisors. They suggested that the front tires on tractor mowers be filled with polyurethane foam. This is expected to save \$4,253 annually in material and time savings for the repair of these tires. This is a partial award pending a final 12-month review.
Edna Gonzales	Police	\$55	Ms. Gonzales is an Intermediate Typist. One year ago she earned a partial award of \$50 for her suggestion to eliminate the copying and delivery of one copy of the jail booking log. One year's savings has shown a savings of \$1,026. This is the remainder of her award.
Ruth T. Nelson Yolanda S. Guaderrama	Personnel	\$55	Ms. Nelson is an Assistant Personnel Analyst. She suggested that only information cards for current or prior City employees be checked at the employment information counter. This is expected to save \$1,130 annually in checking time. This is a partial award pending a final 12-month review.
