

RESOLUTION NO. R-251525Adopted on APR 11980

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Jonathan T. Harker	Building Inspection	\$55	Mr. Harker is an Intermediate Typist. He suggested that a single job order number be used for each Building Inspection auditron. This saves \$571 annually in processing costs.
Bruce L. Freeman	General Services	\$50	Mr. Freeman is a Machinist Supervisor in the Equipment Division. One year ago he earned a partial award of \$50 for his suggestion to purchase nets rather than tarps to cover loads prone to blowing. Total first year's savings were \$1,000. This is the remainder of his award.
Sally A. Dixon	Police	\$50	Ms. Dixon is a Data Entry Operator. She suggested that data entry copies of traffic arrest reports be eliminated. This saves \$525 annually in material and processing costs.
Barbara J. Singley	City Clerk	\$35	Ms. Singley was an Senior Clerk at the time of her suggestion. She suggested that zone outlines be eliminated in mailed notices. This saves \$354 annually in printing and processing costs.
Lauren P. Cordova	City Auditor	\$35	Ms. Cordova is an Intermediate Typist. One year ago she earned a partial award of \$50 for her suggestion to use one job order number per auditron for charging copies. One year's experience has shown a savings of \$844.
