

RESOLUTION NO. R- 251529Adopted on APR 11 1980

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Edgar A. Pompey, Sr.	Park and Recreation	\$10	Mr. Pompey is a Gardener in the Park Division. He suggested that a debris deflector be installed on power lawn edgers. This was considered to be safety improvement.
DeVere E. Brasted	Park and Recreation	\$10	Mr. Brasted is a Center Director I in the Recreation Division. He suggested that the prohibition of glass containers in City parks be extended to all areas. This has resulted in the posting of signs and modifications in vending machines dispensing glass containers. Savings were impossible to calculate, but this was considered to be a significant safety idea.
Betty A. Junghans	Personnel	\$10	Ms. Junghans was an Intermediate Stenographer at the time of her suggestion. She suggested that letterhead envelopes be printed only with building address information. Savings are incalculable at present, but will be evaluated over the next 12-month period.
Raquel E. Quintanar	City Clerk.	\$10	Ms. Quintanar is an Intermediate Typist. She developed tracking forms for Council Docket related reports and records. Although savings were impossible to calculate, this was considered to be a significant operational improvement.
Linda J. Lembo	City Attorney	\$10	Ms. Lembo is an Intermediate Typist. She developed a reminder memorandum for ATSS users. This memorandum will be distributed to each caller not using ATSS when they should have. Savings are impossible to calculate, but this was considered to be a significant operational improvement.
