

RESOLUTION NO. R-251532

WHEREAS, it is the policy of The City of San Diego to facilitate the elimination of County islands and to work toward the ultimate logical boundaries for the City through the annexation process; and

WHEREAS, the property owners have petitioned the City for annexation of a parcel of property located westerly of Friars Road between Margerum Avenue and Deerfield Street known as the Kaiser-Mission Gorge property; and

WHEREAS, said annexation was approved by the Local Agency Formation Commission on July 2, 1979; and

WHEREAS, pursuant to the Proposition 13 implementing legislation of the California Legislature, the City and the County must agree upon the amount of property tax to be apportioned; and


WHEREAS, the County's offer to apportion 13 percent of said property tax to the City for the provision of municipal services would result in actual City expenditures exceeding revenues received; and

WHEREAS, the City Council finds the County's proposed apportionment formula unacceptable; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Board of Supervisors of the County of San Diego is

hereby urged to reconsider its current offer and agree to a formula that provides sufficient property tax to offset the added costs that will be incurred by the City in the provision of municipal services in the annexed territory.
