Hummingbird Lane, a portion of Canary Lane, and Meadow Lark

thereof No. 5322, filed in the office of County Recorder of
San Diego County, January 2, 1964.," is made in the manner

thereon is hereby approved and accepted.


The Clerk of said City is hereby authorized and directed
