That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a deed conveying to SAN DIEGO GAS & ELECTRIC COMPANY, a corporation, an easement for underground and aboveground electrical facilities affecting a portion of Lots 11-12, New Riverside, as more particularly described in said deed on file in the office of the City Clerk as Document No. LAC-251546

3. That the City Clerk of said City is hereby authorized and directed to deliver said deeds, and a certified copy of this resolution, to the Property Director for further handling.
