

RESOLUTION NO. 251557

WHEREAS, a fire occurred in La Jolla at the Boardwalk Condominiums on March 29, 1980, under extremely hazardous fire conditions; and

WHEREAS, this six-alarm incident resulted in the largest mobilization of Fire Department personnel and equipment in this City's history; and

WHEREAS, under windy conditions, the destruction of condominium units was restricted to 22 of 110 units under construction and three of the 96 occupied condominiums; and

WHEREAS, there was no loss of life to the occupants or fire fighters; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council and the citizens it represents does hereby commend the personnel of the San Diego Fire Department for their efficiency and professionalism in controlling and extinguishing a fire of substantial size, thereby preventing the possible destruction of an additional 175 homes, personal property and loss of life.
