

# RESOLUTION No. 1-251558

(R-80-1689 )

Adopted on APR 8 1980

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the low bids of 1. PALOMAR PIPE & SY, 2. PACIFIC PRODUCTS, INC., and 3. HYDRO-SCAPE PRODUCTS, INC., are hereby accepted; and the City Manager is hereby authorized to execute contracts for the purchase of LAWN SPRINKLERS AND IRRIGATION VALVES AND REPAIR PARTS as may be required for a period of one (1) year beginning May 1, 1980 through April 30, 1981 per prices on file in the Purchasing Department as follows:

1. PALOMAR PIPE & SY, for Group I - Toro Sprinklers and Parts and Group IV - Hydro Rain Irrigation Valves and Parts; terms 3% 30 days plus sales tax with an option to renew contract for an additional one (1) year period.
2. PACIFIC PRODUCTS, INC., for Group II - Rainbird Sprinklers and Parts; terms 2% 10 days plus sales tax, with an option to renew contract for an additional one (1) year period.
3. HYDRO-SCAPE PRODUCTS, INC., for Group III - Buckner Sprinkler and Parts; terms 2% 30 days plus sales tax with an option to renew contract for an additional one (1) year period.
