
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a five-year Preferential Non-Exclusive Use and Occupancy Permit with the HOLLINS LAKE SENIOR RECREATIONAL FACILITY, INC., for development, operation and maintenance of a fish farm and recreational facility for senior citizens and the general public, under the terms and conditions set forth in the Preferential Non-Exclusive Use and Occupancy Permit on file in the office of the City Clerk as Document No. R-251559.

BE IT FURTHER RESOLVED, that the City Manager require Hollins Lake Senior Recreational Facility, Inc. to prepare and present a development plan to the Mission Trails Regional Task Force within six (6) months; and,

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to terminate the permit pursuant to the ninety (90) day termination provision in the event such development plan is not prepared and presented as required.
