WHEREAS, the City Council has in Resolution No. 250180 declared that certain weeds, rubbish, refuse and dirt existing on private property more particularly described in said resolution constitute a public nuisance; and

WHEREAS, the hearings provided for in said resolution and required by law have been held and all objections to the proposed removal of weeds, rubbish, refuse and dirt have been fully heard and considered; and

WHEREAS, the Council has in Resolution No. 250230 overruled and denied any and all objections made except for those, more particularly described therein which were allowed; and

WHEREAS, the City Council has in Resolution No. 250229 ordered the Director of the General Services Department of The City of San Diego, the person designated as the Superintendent in this matter, to abate said nuisance by having the weeds, rubbish, refuse and dirt removed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That the report of the Superintendent (General Services Director) showing the cost of weed abatement against each parcel of land in said report be hereby confirmed.

That the Superintendent be hereby authorized to bill property owners for the cost of abatement.
