

RESOLUTION No. R- 251575 (R80-1929 )


Adopted on MAR 31 1980

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and directed to communicate to interested parties that the City Council favors the general concept of an industrial development and shopping center in the Rancho Carmel area of the City of San Diego.

BE IT FURTHER RESOLVED that the City Council's approval in concept is subject to necessary public hearings and assurance of appropriate access and circulation facilities for traffic including Highway 56 and possibly Highway 680 going northwest from Rancho Bernardo to Solana Beach.
