BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a ten (10) year lease agreement with ELEMENTARY INSTITUTE OF SCIENCE of certain property at 608 51st Street, for the purpose of instructing elementary and secondary school children in the principles of science for a total consideration of such utilization plus one dollar (\$1), with a provision authorizing termination by either party on ninety (90) days notice.

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized and empowered to transfer \$85,000 from Fund 245 to the Gas Tax Fund since the property was acquired with Gas Tax monies.
