BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$167,400.00 within Sewer Revenue Fund 41506 from the Unallocated Reserve (70697) to Sewer Construction Outlay, Annual Allocation for Main Replacements.


