BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed  
by EMORY P. GIBLIN, a Registered Civil Engineer, entitled  
"LOGAN PARK VILLAS Being a subdivision of a portion of the  
Southwest Quarter of Lot 54 of a portion of the Ex-Mission  
Lands of San Diego, commonly called Horton's Purchase, in  
the City of San Diego, State of California, according to  
Map thereof No. 283, filed in the office of the County  
Recorder of San Diego County, March 9, 1878.," is made in  
the manner and form prescribed by law and conforms to the  
surrounding surveys; that said map and the subdivision of  
land shown thereon is hereby approved and accepted; and said  
Council hereby accepts on behalf of the public a portion of  
Logan Avenue for public purposes, and said portion of a street  
is hereby declared to be a portion of a public street and  
dedicated to the public use.

The Clerk of said City is hereby authorized and directed  
to endorse upon said map, as and for the act of the Council,  
that said Council has approved said subdivision map and that  
said portion of a public street is accepted on behalf of the  
public as heretofore stated.
