
BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Pursuant to authority conferred by and in accordance with  
the provisions of Section 86.04 of the San Diego Municipal  
Code, PARKING OF VEHICLES IS HEREBY PROHIBITED AT ALL TIMES  
on and along all curbed areas of the following street in said  
City:

Harbor Drive between Eighth Avenue and  
Sampson Street with the exception of the  
southerly side of Harbor Drive from Crosby  
to a point 200 feet westerly.

BE IT FURTHER RESOLVED, that the necessary signs and  
markings be, and the same are hereby authorized to be made  
on said street and that the regulations hereinabove imposed  
shall become effective upon the installation of such signs.
