

RESOLUTION NO. R- 251603

(R. 80-1825)

WHEREAS, the City of San Diego was confronted with a serious situation in the San Carlos community after winter rains activated an ancient landslide; and

WHEREAS, the slipping earth between Rowena Street and Monte Verde Drive had damaged or was threatening approximately 60 homes as well as the public streets and utility lines and connections; and

WHEREAS, the City Council and City Manager assigned the task of finding an expeditious solution to the problem, against overwhelming odds, to CITY ENGINEER JAMES P. CASEY and his staff; and

WHEREAS, JIM CASEY effectively and efficiently marshalled the City's resources to design and carry out a program for reconstruction of the massive slide area to safeguard the remaining neighborhood and avert additional loss of private and public property; and

WHEREAS, JIM CASEY, working closely with the Councilmember representing the San Carlos community in delicate negotiations with residents who were suffering devastating financial and personal losses, assisted the Councilmember in securing neighborhood approval and financial participation in the remedial project; and

WHEREAS, JIM CASEY was also able to secure necessary approval and participation in the reconstruction from the San Diego Unified School District, other governmental agencies, and San Diego Gas & Electric Company; and

WHEREAS, the project was completed successfully in advance of this winter's torrential rains thus preserving most of the homes which were in jeopardy; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the resourcefulness, energy and dedication of City Engineer JAMES P. CASEY, and the staff of the Engineering and Development Department, is deserving of special recognition and commendation on behalf of the San Carlos community and all the citizens of San Diego.
