BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the low bids of 1. WOODWARD SAND & MATERIALS, INC., 2. CONROCK COMPANY, 3. NELSON & SLOAN, and 4. H. G. FENTON MATERIAL COMPANY are hereby accepted; and the City Manager is hereby authorized to execute contracts for the purchase of CONCRETE SAND, PLASTER SAND, CONCRETE AGGREGATE, CRUSHED AGGREGATE BASE, AND FILL SAND, as may be required for the period of one (1) year beginning April 1, 1980 through March 31, 1981, per prices on file in the Purchasing Department as follows:

1. WOODWARD SAND & MATERIALS, INC., for Sections I and II; terms net 30 days, plus sales tax.
2. CONROCK COMPANY, for Sections I and III; terms net 30 days, plus sales tax, with an escalation of \$0.35 per ton effective 9-1-80 through Balance of contract.
3. NELSON & SLOAN, for Section II; terms net 30 days, plus sales tax, with an option to renew contract for a one (1) year period.
4. H. G. FENTON MATERIAL COMPANY, for Sections II, IV, and V; terms net, plus sales tax.
