

The agreement entered into between LA JOLLA ALTA, a California general partnership, and THE CITY OF SAN DIEGO, a municipal corporation, filed in the office of the City Clerk as Document No. 764192, providing for the installation and completion of certain public improvements in LA JOLLA ALTA P.R.D. UNIT NOS. 9 AND 10, be amended to substitute an IRREVOCABLE LETTER OF CREDIT No. L/C SD3135SBY for Exhibit C, which Irrevocable Letter of Credit has been executed by the subdivider, LA JOLLA ALTA, a California general partnership, as principal, and SECURITY PACIFIC NATIONAL BANK, as surety, for the faithful performance of said agreement.

BE IT FURTHER RESOLVED, that the Instrument of Credit in the amount of \$502,502.00 issued by SAN DIEGO FEDERAL SAVINGS & LOAN ASSOCIATION, dated June 14, 1978, be and it is hereby released.
