That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the ATCHISON TOPEKA AND SANTA FE RAILROAD for the cooperative installation of rubber railroad crossing material at the railroad grade crossing on Laurel Street (No. 2-266.6), under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-251639.

BE IT FURTHER RESOLVED, that the expenditure of \$30,000 is hereby authorized from Gasoline Tax Fund 30219 solely and exclusively for the purchase of rubber railroad crossing material.
