WHEREAS, existing departmental appropriations for data processing services were based on the City's best estimate of anticipated computer usage at the time the FY 1980 budget was developed; and

WHEREAS, actual charges to the City Auditor's department, based on computer usage, have increased significantly above the original estimate; and

WHEREAS, this has occurred primarily because of much greater use than originally anticipated by operating departments of the Auditor's new AMRIS accounting system; and

WHEREAS, City-wide, these increased charges to the Auditor have been offset by reductions in cost to other operating departments; and

WHEREAS, it is now necessary to transfer \$485,000 within the General Fund from various departments to the Auditor to accommodate said increased use charges; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller be and he is hereby authorized to transfer within General Fund (100) the sum of \$485,000 to the Auditor and Comptroller's department (050), Object Account 4992 from the following departments in amounts as indicated:
