WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Jeanne E. Totino	City Treasurer	\$ 660	Ms. Totino is an Intermediate Typist. She suggested that the City itemize its ambulance billing to increase its collections for government sponsored medical payments. This was done with a total first year's increase of revenue of \$6,601.
Herbert Michaels	General Services	\$ 500	Mr. Michaels was a Refrigeration Mechanic in the Buildings Division at the time of his suggestion. One year ago he earned a \$500 partial award for his suggestion to revise the heating and cooling unit switch systems at the main Library. Total first year's energy savings were \$12,073. This is the remainder of his award.
Alfred Szymansky	General Services	\$ 300	Mr. Szymansky is a Welder in the Equipment Division. He made several modifications to side-loading refuse vehicles to extend life and reduce maintenance costs. Total first year's savings are expected to be approximately \$6,000. This is a partial award pending a final 12-month review.
Valerie S. Smith	Risk Management	\$ 125	Ms. Smith was an Intermediate Typist at the time of her suggestion. She earned a partial award of \$190 for her suggestion to use an information stamp for Claims Recovery cases. Total first year's savings were \$3,155. This is the remainder of her award.
Phillip J. Love	General Services	\$ 100	Mr. Love was a Carpenter Supervisor in the Buildings Division at the time of his suggestion. One year ago he earned a partial award of \$80 for his suggestion to install 365 series rim fire exit bolts on single exit doors. Total first year's savings were \$1,788. This is the remainder of his award.
