

RESOLUTION NO. R-251654Adopted on APR 22 1980

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Delorese J. Shafer	Risk Management	\$ 40	Ms. Shafer is an Intermediate Typist in the Group Health and Life Insurance Program. She suggested a revision to the filing system of Suggestion Awards Program logs. This simplifies record-keeping and saves an estimated \$400 annually.
Walter R. Newbern	Engineering and Development	\$ 30	Mr. Newbern is an Associate Land Surveyor. He suggested that tools be purchased to repair measuring tapes. This saves \$300 annually in repair time.
Adolph G. Labiak	Park and Recreation	\$ 20	Mr. Labiak is a Park Supervisor in the Park Division. He suggested that different colored service requests be used to identify responses to storm related emergencies. Although savings were impossible to calculate, this was considered to be a significant operational improvement.
George R. Ikeda	General Services	\$ 15	Mr. Ikeda is a Carpenter in the Buildings Division. He suggested that the sideboards on stake bed trucks be redesigned. This is expected to save \$113 annually in repair costs.
James K. McCormick	General Services	\$ 10	Mr. McCormick is a Building Manager in the Buildings Division. He suggested that the glue-down method be used to reinstall Guideline Walter Carpets. Although this was too expensive to contemplate, the suggestion did result in procedure changes to prevent carpet damage.
