Thomas C. Feldscher	Fire	\$ 10	Mr. Feldscher is a Fire Fighter. He suggested that high backed seats be installed on apparatus #1306. Although this was not done, high density rubber strips were attached to the window behind the seat. This was considered to be a significant safety improvement.
Faye L. Walsh	Fire	\$ 10	Ms. Walsh is an Intermediate Typist. She suggested that City employees be reminded of the savings to be achieved by using ATSS. This will be done periodically in the PDL. This was considered to be a significant operational improvement.
Delorese J. Shafer	Risk Management	\$ 10	Ms. Shafer is an Intermediate Typist in the Group Health and Life Insurance Program. She suggested that Suggester Record Cards be preprinted with standard information. First year's savings are expected to be \$46.
