VACATION OF BEECH STREET, CEDAR STREET,
35TH STREET, AND PORTIONS OF ASH STREET
AND PENNELL AVENUE

WHEREAS, it is proposed that BEECH STREET, CEDAR STREET,
35TH STREET AND PORTIONS OF ASH STREET AND PENNELL AVENUE,
located northwesterly of Ash Street and Pennell Avenue be
vacated; and

WHEREAS, there is no present or prospective use for the
streets either for the public street system for which the
right-of-way was originally acquired or for any other public
use of a like nature that can be anticipated; and

WHEREAS, the public will benefit from the vacation through
improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent
with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-
way was originally acquired will not be detrimentally affected
by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
California, that BEECH STREET, CEDAR STREET, 35TH STREET AND
PORTIONS OF ASH STREET AND PENNELL AVENUE, located northwesterly
of Ash Street and Pennell Avenue, as more particularly referred
to in Resolution of Intention No. R- 251521, are
unnecessary for present or prospective public street purposes.


BE IT FURTHER RESOLVED, that BEECH STREET, CEDAR STREET,
35TH STREET AND PORTIONS OF ASH STREET AND PENNELL AVENUE,
located northwesterly of Ash Street and Pennell Avenue, as more

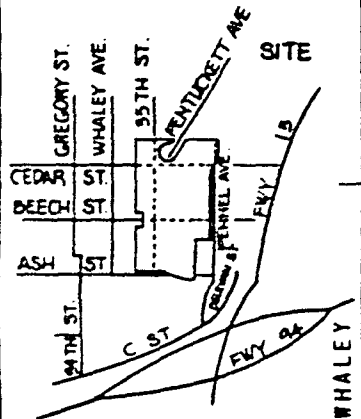
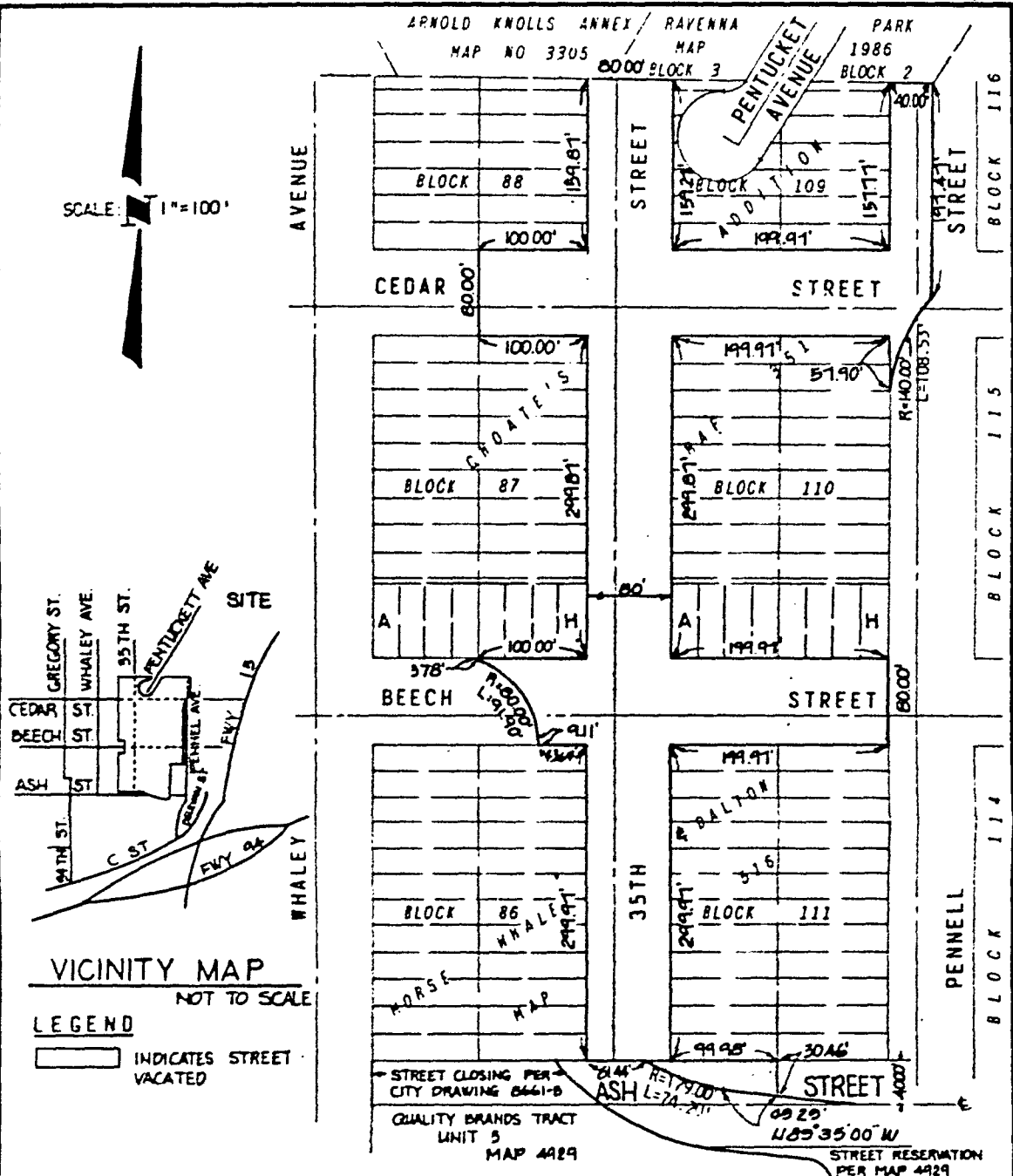
