BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$47,550.00 from Park and Recreation Bond Fund Reserve CIP 90-725, and \$7,450.00 from Park Bond Fund 30725 CIP 21-351, to CIP 21-364 Balboa Park Rose Garden - Erosion Control Improvements.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$105,000.00 from Capital Outlay Fund 30245 and \$55,000.00 from Park and Recreation Bond Fund CIP 30725 of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
