

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an agreement with ENGINEERING-SCIENCE for the purpose of performing a water and sewer facilities feasibility study of the Otay Mesa area, under the terms and conditions as set forth in that agreement a copy of which is on file in the office of the City Clerk as Document No. RR- 251670.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed the sum of \$51,000 within Water Operating Fund (41500) from the Unallocated Reserve (70669) to Utilities Engineering Services (70649) for said services and related costs, is hereby approved.


