
BE IT RESOLVED, by the Council of The City of San Diego as follows:

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$4,000 from CIP 39-004 "Miscellaneous Parcels for Right-of-Way, Open Space and Other Public Purposes" for acquisition and related costs is hereby authorized and approved.
