BE IT FURTHER RESOLVED, that the City Manager is authorized without further Council action to go to bid (when necessary) and to execute contracts for consultant services, lease/rental services, equipment purchases, and all other related contracts and agreements specified in the grant contract (including any extension or amendment thereof).

BE IT FURTHER RESOLVED, that \$10,000 of City funds is authorized to be expended to provide the required matching funds as set forth in the grant contract.

BE IT FURTHER RESOLVED, that the City Manager, acting through the Personnel Department, is authorized to hire a full-time Police Sergeant, two full-time Police Officers, one full-time Intermediate Typist and a half-time Administrative Analyst as limited positions for purposes of fulfilling the grant contract.
