

RESOLUTION NO. R-251728 (R.80-1882)

APR 29 1980

WHEREAS, the City Council has conceptually approved a \$150 million Tax Exempt Mortgage Revenue Bond Program which will, if implemented, provide financing for the construction of affordable multi-family rental housing; and

WHEREAS, numerous planning, development and implementation decisions will be necessary in going forward with the bond program, and the San Diego Housing Commission has requested the authority to make such decisions in order to expedite the development of the program; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the San Diego Housing Commission is hereby authorized and empowered to make all decisions relating to planning, development, and implementation of the Tax Exempt Mortgage Revenue Bond Program, as identified on the attachment hereto which is by this reference incorporated herein; and

BE IT FURTHER RESOLVED, that this delegation shall not include the right to execute contracts or enter into any binding commitments with regard to the bond program except for such commitments which will be solely the responsibility of the Housing Commission and for which funds are available in the Housing Commission's approved budget.
