WHEREAS, the City Council has in Resolution No. 251567 confirmed the cost of weed abatement against the parcels of land in the Superintendent's (General Services Director) report; authorized the Superintendent to bill the property owners; and directed the City Clerk to forward the Superintendent's report to the County Auditor on or before August 10, 1980.

WHEREAS, the City Council has held special meetings on February 19, March 17, April 8 and April 29 to hear protestors regarding their clean up assessments; to confirm the costs of weed abatement regarding the protestor's parcels and to authorize billing; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. The cost to Robert Changnon be amended to \$80.00 because the billing information did not reach him until after the clean up, the information having been sent to previous owners.
- 2. The cost to Goodall Bus Company be amended to \$250.00 because the company was given incorrect information as to the potential cost of abatement.
- 3. The staff's recommendations as modified by Council be accepted and an amended report filed in the Clerk's Office, which amended report shall contain all adjustments in administrative costs prior to hearing on April 29, 1980 and the basis upon which Council made its decisions.

4. The City Clerk is hereby directed to forward a certified copy of this Resolution together with a copy of said amended report to the office of the San Diego County Auditor on or before August 10, 1980.
