WHEREAS, the contract of The City of San Diego for maintenance and operation assistance of the Convention and Performing Arts Center (hereinafter referred to as "services") will end on April 30, 1980; and

WHEREAS, the City is in the process of preparing a request for proposals for a new contract; and

WHEREAS, in the interim there is an immediate need to enter into a temporary contract to perform said services commencing May 1, 1980; and

WHEREAS, Bekins Building Maintenance Company (hereinafter called "Bekins") has submitted a Letter of Intent dated April 23, 1980 addressed to the Convention and Performing Arts Center offering to provide services as set forth therein; and

WHEREAS, the Council desires to accept said offer for services to commence May 1, 1980 and continue on a month to month basis pending the execution of a formal contract for a longer term; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The offer of Bekins to provide services at the Convention and Performing Arts Center as set forth in that letter dated April 23, 1980, on file in the office of the City Clerk as Document No. R-251732, be and the same is hereby accepted on a month to month basis, as may be required, commencing May 1, 1980 and terminable at the option of City at

the end of any month on seven (7) days' prior written notice to Bekins.

2. Bekins' agreement to the provisions of this resolution shall be signified by a letter of concurrence addressed in the same manner as the April 23, 1980 letter. The original of the letter of concurrence shall be filed in the office of the City Clerk with this resolution.
