

RESOLUTION No. R-251735 (R-80-1982)

Adopted on MAY 5 1980

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. NEPTUNE WATER METER COMPANY, 2. ROCKWELL INTERNATIONAL, 3. BADGER METER, INC. and 4. HERSEY PRODUCTS INC. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of WATER METERS AND PARTS as may be required for a period of one (1) year beginning March 1, 1980 through February 28, 1981 per prices on file in the Purchasing Department as follows:

1. NEPTUNE WATER METER COMPANY for Schedule II - Items 1 through 4 and for parts for Neptune meters; terms net 30 days plus sales tax, with an option to renew for an additional one (1) year period at prices not to exceed 10% of bid prices.
2. ROCKWELL INTERNATIONAL for Schedule II - Item 5, Schedule III - Items 1 and 2 and parts for Rockwell meters; terms net 30 days plus sales tax, with an option to renew for an additional one (1) year period.
3. BADGER METER, INC. for Schedule III - Item 3 and for parts for Badger meters; terms net 30 days plus sales tax, with an option to renew for an additional one (1) year period.
4. HERSEY PRODUCTS INC. for Schedule IV - Items 1 and 2 and parts for Hersey meters; terms net 30 days plus sales tax.
