CHRISTENSEN, a Registered Civil Engineer, entitled "VILLA DEL SOL Being a subdivision of Lots 8, 9 and 'A' in Alvarado Plaza Subdivision Unit No. 3, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 6072, filed in the office of the Recorder of San Diego County, March 20, 1968.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.

ASSOCIATES, a general partnership, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of VILLA DEL SOL.
