

RESOLUTION NO. R-251750 (R.80-1947)

MAY 5 1980

WHEREAS, a certain drainage easement was acquired without cost for drainage purposes for construction of a frontage road easterly of I-5 now within the subdivision known as Park Santa Fe Unit No. 1; and

WHEREAS, the present development of the property required the quitclaim of the existing drainage easement; and

WHEREAS, this aforementioned drainage easement will no longer serve the public purpose for which it was originally acquired; and


WHEREAS, the City has no present or prospective public use for the drainage easement, and the City Manager has recommended that the City abandon its interests therein; and

WHEREAS, the drainage easement has only a nominal value under the circumstances and S.G.B. CORPORATION has paid all City costs in connection with processing the matter of quitclaiming the easement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, on file in the office of the City Clerk as Document No. PR-251750-1, quitclaiming to S.G.B. CORPORATION, a California corporation, all the City's right, title and interest in the drainage easement, as more particularly described in said quitclaim deed.
